Whereas, it is observed that the plastic carry bags also cause blockage of gutters, sewerage system and drains thereby resulting in unhygienic environmental and public health related problems.

AND

Whereas, it is observed that plastic carry bags are non-biodegradable and after hundreds of years breaks to toxic plastic particles polluting soil; produces toxic gases and ash on it's burning.

AND

Whereas, it is observed that the plastic carry bags cause aquatic and terrestrial animals die by its ingest, it's litters arrest the recharging ground water aquifers; harmful chemicals and colours of plastic contaminates soil and water; plastic carry bags chokes the living organisms of the soil etc causes harmful effects on the environment.

AND

Whereas, the plastic carry bags adversely affects on percolation of water to ground levels, hamper the quality of soil layer, effect the growth of roots & plants and creature etc which causes long term bad effect on ecology & environment.

AND

Whereas, a draft notification, in accordance with order dated 09.01.2015 passed by the Hon'ble High Court of Tripura in W.A.4 of 2014 and in exercise of the powers conferred by section 5 of the Environment (Protection) Act, 1986 (29 of 1986), and also the powers conferred to this State vide Notification No.S.O.479 (E) dated the 25th July,1991 under Section 23 of the Environment (Protection) Rules, 1986, was published in Tripura Gazette vide No.F.8(30)/DSTE/ENV/Pt-II/361-80 dated 22/01/2015 by the Government of Tripura, inviting objections and suggestions from general public with respect to the said notification within 15th February,2015 from the date of the publication of the said notification.

AND

Whereas, the objections and suggestions received from the public with respect to the said draft notification have been considered and dully disposed of.

Now, therefore, in exercise of the powers conferred by section 5 of the Environment (Protection) Act, 1986 (29 of 1986), and also the powers conferred to this State vide Notification No.S.O.479 (E) dated the 25th July,1991 under Section 23 of the Environment (Protection) Rules, 1986, the Government of Tripura issues this Notification to impose a complete ban on the manufacture, import, storing, transport, sale and use of plastic carry bag(s) in the whole state where the ban shall be given effect after a period of 3(three) months from the date of publication in the Official gazette. **In this context, the Government hereby issues the following directions namely:-**

Directions:-

1. No person including a shopkeeper, vendor, wholesaler or retailer, trader, hawker or fehriwala (i.e, which shall include all kinds of hand pushed/pulled carts which are used to sell various commodities), shall sell or store or use any kind of plastic carry bags for storing or dispensing of any eatable or non-eatable goods or materials.

2. No person shall manufacture, import, store, sell or transport any kinds of plastic carry bags (including that of Poly Propylene, Non-woven fabric type carry bags) in the whole of State of Tripura.
3. No person shall use any kind of plastic cover or plastic sheet or plastic flim or plastic tube to pack or cover any book including magazine and invitation card or greeting card.

Exception:-

The direction issued under this notification shall not affect the use of plastic carry bags as specified under the Bio-Medical Waste (Management and Handling) Rules, 1998, as amended to date.

Explanation:-

For the purpose of this Notification " plastic carry bags" shall have the same meaning as defined in the Plastic Waste (Management and Handling) Rules, 2011, issued by Government of India, Ministry of Environment and Forest, which is reproduced as below:-

'Carry bags' mean bags made from any plastic material, used for the purpose of carrying or dispensing commodities but do not include bags that constitute or form an integral part of the packing in which goods are sealed prior to use.

Authorized Officers:-

The following officers are hereby authorized to implement this Notification in their respective jurisdiction namely:

1. Member Secretary, Tripura State Pollution Control Board and Officers at the level of Junior Environmental Engineer/Junior Scientist and above.



2. Director, Department of Science, Technology & Environment, Government of Tripura and Officers at the level of Scientific Officer and above.
3. Chief Executive Officer, Agartala Municipal Council, Agartala and other Officers nominated by him.
4. The Chief Executive Officer of Tripura Tribal Area Autonomous District Council, Tripura and other Officers nominated by him.
5. District Magistrate & Collectors of all respective District in Tripura.
6. Superintendent of Police & Officers at the level of Sub-Inspector of Police and above.
7. Director, Food and Civil Supplies Department and Officers at the level of Inspector and above.
8. Director, Industries & Commerce Department and other Officers nominated by him.
9. Director, Health & Family Welfare Department or other Officers nominated by him.
10. Commissioner of Taxes & Excise and Officers at the level of Inspector of Taxes and above.
11. Labour Commissioner, Labour Department and Officers at the level of Inspector and above.
12. Sub-Divisional Magistrate of all respective Sub-Division in Tripura.
13. Block Development Officer of all respective block in Tripura.
14. Controller, Weights & Measure Department and Officers at the level of Inspector and above.
15. Executive Officer of all respective Nagar Panchayet in Tripura.

Monitoring:-

The Member Secretary, Tripura State Pollution Control Board (TSPCB) shall ensure over all monitoring and implementation of these directions. The Chairman and the Member Secretary, TSPCB and all the Authorized Officers mentioned in foregoing para within their respective area/jurisdiction, are authorized to file complaint under section 19 of the Environment (Protection) Act, 1986.





NOTIFICATION

In the greater public interest and protection of ecology and environment, it has been decided that for effective control of use of unauthorized plastic carry bags, pollution cost will be realized in the following manner:-

Sl. No.	Pollution Cost to be Imposed	Pollution Cost Rs.
a)	Permanent Shops/Establishments	i) Rs.1000/- only in case of first offence. ii) Rs.2000/- only for Second offence. iii) Rs.3000/- only for Third & Subsequent offence.
b)	Temporary or mobile shops/establishments	i) Rs.500/- only in case of first offence. ii) Rs.1000/- only for Second offence. iii) Rs.1500/- only for Third & Subsequent offence.
c)	Individual User	Rs.100/- Only.

2. Such pollution cost will be imposed by the officer not below the rank of Assistant Sub-Inspector of Police under control of Sub-Divisional Police Officer (SDPO) in each Sub-Division and also by the 'Authorized Officers' designated to implement the Notification No.F.8(30)/DSTE/ENV/Pt-II/1679-97 dated 10.03.2015 in their respective jurisdiction. **The amount collected as 'pollution cost' will be centrally deposited in the Savings Account Number - 33906035634 (which is in favour of Member Secretary, Tripura State Pollution Control Board) at State Bank of India, TLA House Branch, Colonel Chowmuhani, Agartala** to utilize the fund for the purpose of environment up-gradation in the state. Tripura State Pollution Control Board (TSPCB) will look after the overall function of the Bank Account and also proper utilization of fund collected in the Account for audit purpose.

3. It is made clear that at the time of imposition of 'pollution cost' and collection from the shop keepers or from any individual as per the quantum referred above, proper receipt should be given by the all concerned as document.

4. Proper accounting should be made by the all concerned and also by the Tripura State Pollution Control Board, so that the State Level Advisory Body [constituted under the provision of the Environment (Protection) Act, 1986 and the Plastics Waste (Management and Handling) Rules, 2016] from time to time can supervise the work of the implementing agencies for proper and effective execution of Ban Order and towards protection of Environment.

5. Manufacturers, Stockiests, Users and transporters of unauthorized plastic carry bags are liable to face prosecution and other regulatory order as confirmed under Environment (Protection) Act, 1986 and Rules made there under, apart from the aforementioned payment of pollution cost.

6. During raids conducted by the all above mentioned "Authorized Officers", local police will give full co-operation and in case of refusal to pay 'pollution cost', police authorities will take necessary action in accordance with law.
