NOTIFICATION

In exercise of the powers conferred by section 54 of the Air (Prevention & Control of Pollution) Act, 1981 (14 of 1981), the Governor of Tripura hereby makes the following rules further to amend The Tripura State Pollution Control Board (Control of Air Pollution) Rules, 1989.

1. Short title and Commencement

(i) These rules may be called **The Tripura State Pollution Control Board (Control of Air Pollution) Third Amendment Rules, 2010.**

(ii) They shall come into force on the date of their publication in the official Gazette.

2. In Sub rule (1) of Rule 8 of the Tripura State Pollution Control Board (Control of Air Pollution) Rules, 1989 the following shall be Substituted.

“ An Application for obtaining the consent of the State Board as required under section 21 for operating as industrial plant, for the purpose of any industry specified in the Schedule appended to the Act, in an air pollution Control area declared as such under 19 shall be made to the State Board in such form as the Board may prescribe from time to time

provided that where any person immediately before the declaration of any area as air pollution control area operates in such area any such industrial plant, he shall make such application in the specified form within a period of three months from the date of such declaration”.

(3) In Sub rule (2) of Rule 8 of the Tripura State Pollution Control Board (Control of Air Pollution) Rules, 1989 the following shall be substituted.

“The application made under Sub rule (1) shall be accompanied by an amount of Consent fees as notified by the Government from time to time.”

(4) Form -1 appearing after rule 19 stands deleted.
